The Stewards, having received a report from the Asian Le Mans Series Technical Delegate, interviewed both the team manager and the driver named below, have considered and reviewed the following matter, determined a breach of the regulations has been committed by the competitor named below and have decided to impose the following penalty:

Session Race 2

Facts The driver was found to be wearing shoes and gloves with a counterfeit FIA homologation sticker

Offence Article 4.1.1 of the Asian Le Mans Series
Article 12.2.1.c of the FIA International Sporting Code

Decision A fine of Euro 10,000 imposed on the driver.

The matter to be reported to the parent ASN of the Series – the Automobile General Association Macau-China (AAMC).

Reason The driver has readily admitted to the offense motivated by his personal superstitious beliefs. He added that the act was of his own decision and responsibility.

The Stewards found no ground to impose any penalty/ies to the Competitor,

who, in fact, provided their drivers the proper equipment nor to penalize the other members of the crew by imposing a sporting penalty to the entry.
